GENERAL PRICE LIST

These prices are effective as of May 21, 2023

The Federal Trade Commission and the New York State Department of Health require certain disclosures on The General Price List. The statements say the same thing in slightly different wording, however both authorities require it be stated in their exact wording so throughout the price list you will see disclosures from both authorities. NYSDOH- "The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected."

(2) "This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected."

FTC- The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

ALTERNATIVE SERVICES

The following charges for direct burial and direct cremation do not include additional items or services, merchandise, facility use, and livery that the customer may wish to select. Only the items listed in the following descriptions are provided.

DIRECT CREMATION:

Our charge for direct cremation includes local transfer of remains to the funeral home, funeral director services, securing of necessary authorization, basic local transportation to the crematory, and return of the cremains to the funeral home in a rigid, temporary container.

Direct Cremation with cardboard cremation (alternative) container **1,900.00**

Direct Cremation with cremation container provided by client. **1,850.00**

NYSDOH-"The direct cremation prices do not include the crematory charge."

NYSDOH- "If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials."

DIRECT BURIAL **1900.00**

Our charge for direct burial includes local transfer of remains to the funeral home, Funeral Director services, securing necessary authorization, topical disinfection, dressing, and casketing of deceased, an alternative container, and basic local transportation to the cemetery.

Container provided by family **1850.00**

TRANSFER OF REMAINS **No Charge (Local)**

Local: Within 10 miles of funeral home, \$2.00 per mile after 10 miles **may** be charged
The transfer of remains to the funeral establishment includes Funeral Director, equipment, and vehicle.

PREPARATION OF REMAINS

Embalming **600.00**

NYSDOH- "In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm."

FTC- Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

NYSDOH- "The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains or receiving of remains because the prices for those services include this charge."

FTC- This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

LIMITED SERVICES

Forwarding Remains **1200.00**

Includes transfer of remains to funeral establishment, securing necessary authorizations, the services of the funeral director and staff and local transportation of the remains to point of shipment. Common carrier charges are charged as a cash advance.

Receiving Remains **1200.00**

Includes transfer of remains to funeral establishment and/or place of local disposition, securing necessary authorizations, the services of the funeral director and staff.
